ARTISTS

Entrants must be at least 21 years of age to enter and must also be residents of FALL CREEK, STONY CREEK, ADAMS OR GREEN TOWNSHIPS at the time of the exhibit. Any art media except video art is welcome.

Artists may enter up to 3 pieces not previously exhibited at the South Madison Show.

ENTRY SPECIFICS

For the protection of your art, two-dimensional art must be properly mounted or framed ready to hang with wire. Paint and sealer must be dry. Hanging entries are limited to 60 inches and 10 pounds. Three dimensional art is limited to 60" in any direction and 50 pounds.

A single entry of any type is limited to 4 components
